Style and rules for contributors for the English Edition

1. Journal of International Cooperation in Education is an international refereed journal published twice a

year once in Japanese and once in English. The English edition of the journal welcomes articles from

authorized contributors (see "2") on international cooperation in education, educational development or any

related aspects of the field.

2. Qualification of contributors is given to individuals associated with the Center for the Study of International

Cooperation in Education, Hiroshima University including current and former CICE staff members, members

of the managing committee, research fellows, and visiting research fellows. Contributions for articles may

also be invited by the JICE Editor-in-Chief. Otherwise submissions from anyone interested in CICE activities

can submit his/her manuscript to the journal if accompanied by an introduction of a CICE staff or any

associate member.

3. Manuscripts should be original and clearly and precisely written in English. Text should be prepared using

Microsoft Word software. Contributor(s) shall submit the manuscript electronically by sending to the CICE

administrative office: cice@hiroshima-u.ac.jp. An acknowledgement of receipt of the manuscript shall be sent

within 3 working days.

4. Each submission should be no longer than 7000 words (14 printed pages) in total, including title, author(s)

information, tables, figures and references. Each article should be accompanied by an abstract of

approximately 150 words typed on a separate sheet.

5. Preparation of Manuscript:

A. Cover sheet should contain title, full name, institution, address, phone and fax numbers, and e-mail

address.

B. Text should be typewritten on one side of A4 size paper with 30 mm margins on all sides. Each

typewritten page should have 42 lines, approximately 500 words with 10.5 point character.

C. References

All manuscripts shall follow the Publication Manual of the American Psychological Association (APA) 6th

edition (2010). A brief summary is in "styles and rules for contributors 2"

D. Tables should be self-explanatory and each presented on a separate page outside the main text. A short title

should be provided with any additional information contained in footnotes with a lucid legend to explain the

meaning of the content.

E. Figures are referred to for all drawings, diagrams, graphs and photographs. These should be of the highest

quality and suitable for direct reproduction. Each figure should be presented on a separate page.

F. Place of insertion of tables and/or figures in the text should be indicated on the right-hand margin of the

sheet.

6. Whether or not the manuscript is accepted and the timing of publication is decided by the Editorial

Committee. The positions and scale of figures and tables in published pages may be changed from the

author's designation.

7. Galley proofs will be sent to the corresponding author if there is sufficient time to do so. The authors are

responsible for reading the first galley proof. No change of the content of the manuscript is permitted on the

galley proof without the consent of the Editor-in-Chief.

8. **Off-prints.** Authors will receive 30 offprints free of charge. Additional copies can be obtained at the author's

cost.

9. Copyright. The articles published in the Journal of International Cooperation in Education are subject to

copyright. All rights are reserved by the Center for the Study of International Cooperation in Education

(CICE), Hiroshima University. Authors may, of course, use the article elsewhere after permission is obtained

from CICE.

Formatting Basic Rules

Beginning with the volumes published in 2012, the Journal of International Cooperation in Education (hereinafter, JICE) shall basically follow *Publication Manual of the American Psychological Association* (APA) 6th edition (2010), which is most commonly utilized to cite sources in social science.

(In-text citation)

- ✓ Reference to books, monographs, articles and statistical sources have to be identified within the text by the author's family name, publication year, and pagination, where appropriate.
- ✓ When the author's name appears in the text, cite as, e.g., Sato (1986). When the author's name does not appear in the text cite as (Sato, 1986).
- ✓ When citing pagination from a quote or specific reference, write as (White, Salmon, & Kelly 1990, p.90).
- ✓ Distinguish more than one reference to an author in one year by utilizing lowercase letters (a, b, c) next to the publication year: (1999a), (1990b).
- ✓ When the citation includes two or more works, order them the same way they appear in the reference list (by <u>alphabetical order</u> not by year), separated by a semi-colon. (Johnson, 2004; Sasaki & Sato, 2000; White, 2001).

(Reference list)

- ✓ All lines after the first line of each entry in your reference list should be indented one-half inch from the left margin (hanging indentation).
- ✓ Authors' names are inverted (last name first); give the last name and initials for all authors of a particular work.
- ✓ Reference list entries should be alphabetized by the last name of the first author of each work.

- ✓ Capitalize all major words in journal titles.
- When referring to books, chapters, articles, or webpage, capitalize <u>only</u> the first letter of the first word of a title and subtitle, the first word after a colon or a dash in the title, and proper nouns. Do not capitalize the first letter of the second word in a hyphenated compound word.
- ✓ <u>Italicize</u> titles of longer works such as books and journals.
- ✓ For details, consult the Publication Manual of the American Psychological Association (APA) 6th edition (2010). However, if you have any source that APA does not include, please cite it using the most similar type from APA 6th edition.
